

YOU HAVE BEEN ISSUED A CITATION. PLEASE READ THE FOLLOWING INSTRUCTIONS VERY CAREFULLY.

You must make an appearance in court between 5 and 14 days after the issuance of the citation. That can usually be done either by payment of bail (**option 1**) or by scheduling a date to appear personally in court (**option 2**). You may choose to hire a lawyer to make an appearance. Failure to appear as required may result in the issuance of a warrant for your arrest and the suspension of your driver's license. Utah is a member of the Interstate Driver License Compact. Accordingly, a suspension of driving privileges in Utah may result in a suspension in the issuing state.

If you desire to pay the bail (**option 1**), please refer to the bail amounts listed in this form, complete the payment of bail information herein, and forward the entire payment to the appropriate court. Some courts have an online payment option. If you need help making the payment, or want to make the payment over the phone, contact the appropriate court office. The name of the court should be on the left side of your citation. See the contact info on the back of this form. (Note: Some offenses require a court appearance and can't be completed through option 1.)

If you desire, or are required, to make a personal appearance in court (**option 2**), **YOU MUST CALL THE COURT CLERK FOR AN APPOINTMENT WITH THE JUDGE** or stop in at the court office and ask for an appointment. If you desire to set up a payment plan with monthly payments for the fine, you will need to arrange a court hearing with the judge. You may request that the court allow you to perform community service in lieu of paying some, or all, of a fine for class B and C misdemeanors and infractions. Community service will be credited at a rate of \$10/hour. Please contact the court to make an appearance before the judge, if you would like to request community service in lieu of paying your fine. (UCA 76-3-301.7.)

When remitting bail, failure to notify the court of your desire to contest the charge(s), or failure to appear for a court hearing, may be considered a forfeiture of bail. Forfeitures of bail are recorded as convictions.
